However, it's vital that all employees (including emergency responders) who are handling and managing these Pressurised Tank Containers are scheduled for the Mandatory IMDG Code trainings (offer by ATCA & approved by the Maritime and Port Authority of Singapore (MPA) when selecting the correct tank unit (by the T-code/ADR Code) before loading the HazMat into these tank containers. Besides, they must be equipped with the latest Emergency Response Information and Technical knowhow when there is an Emergency Situation involving tank container. The presentation will covers: 1. What is an ISO-tank Container? 2. How to Identify the ADR Code & T-codes before selecting the correct Tank Container meant for Flammable Materials (FM); 3. The Fire Safety Functions of the Tank Parts & Components – e.g. Fusible Link/ Bursting Disc/Shut-off cable/ Temperature & Pressure Gauges/ Pressure Relief Valves/ Vacuum Relief Valves; 4.
