Developing Emergency Management Capability for SMC, SIC, FSM and Emergency Planners

Unlike other disciplines of resilience management, emergency management is the 'sprinting element' of managing the direct consequences of an incident. It is immediate, decisive and quickest to end among other disciplines of resilience management. Pegged at the Tactical and Operational levels of response, it has a direct impact and link to the Strategic level of response to ensure alignment to organisational goals.

This Workshop has touchpoints across the pre, during and post incident phases. The trainers will use real life experiential sharing in both the private and public sectors. The workshop has all the elements to evoke your senses so that you will take away the knowledge and experiences in your familiar styles of learning.

It will make you Rethink about the value of the Emergency Response Plan; Redefine your scope of Emergency Preparedness and Response; and Redesign your Emergency Capability based on your risks, risk appetite, firefighting strategy, and the national authority's capabilities.

WORKSHOP SPEAKER PROFILE

Mr. Noor Azlan is a Business Continuity Management, Crisis Management, Emergency Response and Fire Safety practitioner and trainer with 27 years of experience. He is versatile in both public and private sectors.

While in the Singapore Civil Defence Force (SCDF), he was awarded the National Commendation Medal (2011); and the Overseas Service Medal (1999) for his role as Head of Operations in the Ops Lionheart mission. He was a former Commander of a fire station in Singapore. While in the Civil Defence Academy, he had successfully trained and prepared over 4,500 Emergency Response Specialists and 1,000 Senior Officers to take on their frontline roles in SCDF.

Azlan held a global responsibility for the EMAS Group (upstream oil and gas and marine services business) in the fields of Emergency Response, Crisis Management, and Business Continuity Management. He is a proven and tested expert in his field and he had won the prestigious Best Continuity and Resilience Consultant in Asia in 2017, awarded by the Business Continuity Institute (UK). He had also attained the Top 100 Trusted SME in Singapore in 2018 as part of the Singapore Enterprise Medal of Honour.

He trains professionals regularly in emergency response planning for both commercial and industrial premises across Asia, Middle East and Africa. Azlan is an Associate Faculty member of the National University of Singapore and the Singapore University of Social Sciences where he lectures on the entire spectrum of resilience management and fire safety related topics.

WORKSHOP SPEAKER PROFILE

Mr. Andy Choo had through his 18 years of service in the SCDF represented SCDF in conducting at least 12 conference talks on fire investigation case studies and fire statistics, to a total of about 15,000 fire safety managers and industrial experts. His certifications, training and experience gained from the many fires he investigated saw him administering and facilitating the learning of about 40 dedicated fire investigation courses for SCDF frontline leaders and forensic investigation units from local and overseas agencies. He has also peer-reviewed more than 5,000 fire reports, investigated and created over 300 detailed fire investigation reports. Andy represented the SCDF on multiple occasions in the State Court as the expert witness.

Valuable insights gained from his training stint, incident mitigation, exercise planning and preparation allowed Andy to put his readiness and emergency preparedness knowledge to good use. As the Chief Inspectorate, he audited the emergency preparedness of SCDF's operations and validated the enterprise risk management measures of the organisation. As Commander of Woodlands Fire Station, he commanded the extinguishment of huge fire and rescue incidents with his crew, as well as planning for and executing emergency preparedness exercises of national scale at high-risk installation in the northern sector of Singapore.
